Dear Valued Stepping Stone School Families:

We appreciate your ongoing partnership with Stepping Stone school as we navigate the COVID-19 issues together. As a school community, we remain vigilant and proactive in taking the appropriate actions and precautions to safeguard the health and welfare of our school community, while still maintaining as much educational continuity and consistent routine as possible for our students.

I wanted to update all of you regarding continued and additional steps that Stepping Stone School is taking. Also, please review my letters of February 27th and March 10th for previous information provided to families.

- As of Monday, March 16th, all of our playground equipment will be sanitized with disinfectant at the end of the day and air dried overnight. This service will take place nightly by our cleaning company Shining Image.
- Our cleaning company also uses vacuums with HEPA (High-Efficiency Particulate Air) filters, which filter out airborne particles. These same HEPA filters are used in many hospitals to enhance air quality within this environment.
- Out of an abundance of caution, we are cancelling the field trip to the movies that had been planned for Spring Break next week for our school age children.
 The children will still visit *The Atelier™* which is located at our Lakeline campus.
- Beginning immediately, all school age children being picked up by Stepping Stone School at elementary schools will have their hands washed at school, and then sanitized before they enter our vans. Once they enter Stepping Stone School, they will wash their hands again, adhering to the CDC guidelines.
- The Texas Department of Family and Protective Services requires that all
 licensed early care and education programs do a wellness check of every child
 when they arrive at school. These checks take place at every Stepping Stone
 School daily. Should any child or staff member exhibit the symptoms of COVID19, they will be immediately separated and sent home to consult with a doctor.
- We will continue to require all students and staff to be fever free (temperature taken with an oral thermometer) for 24 hours without taking medication, before they may return to Stepping Stone School. Of course, if a student or employee are suspected of having COVID-19 and have been advised by their physicians to be quarantined, they will not be allowed to return to the school without clearance from local health officials.
- Should we be required to close a school due to COVID-19, we will strictly follow all local health department requirements and guidelines and provide continued updates to our families.
- A Safety Council has been formed within Stepping Stone School which consists
 of top administrators, local medical professionals and advisors from the Early
 Care and Education Consortium (ECEC) out of Washington, D.C. who are
 receiving continuous updates from the CDC and passing them onto us.
